Public Comment

Ed Taylor at 213 Northeast St. appeared before the council to express concern about the new owner of the senior citizens building becoming apartments and having an absentee landlord. The new owner is from Edwardsville, he would not like to see it rezoned.

The mayor informed the public that the water bill policy is changing, shut off notices will no longer be sent out. The new policy will be stated on the water bills.

Old Business

New Street Light/303 W. 1st South - A resident requested a new street light at 303 W. 1st South, Aldermen Ober, Harber and Downey looked at it, and did not deem it necessary for a new light.

New Business

Ordinance Implementing a Municipal Grocery Retailers Tax – The council passed the ordinance implementing a 1% grocery tax, the state will abolish the tax in 2026 and the local municipalities can then pick up the tax as a replacement tax. A motion was made to approve by Alderman Ober, seconded by Downey, motion passed unanimously.
